**Call to Order**

- Dr. Raymond Moreno called the meeting to order at 1:47 P.M.

**Public Comments**

- There were no public comments.

**Approval of November 3, 2021 Minutes (Attached)**

- Mr. Hathaway made a motion to approve the minutes from the November 3, 2021 meeting. The motion was seconded by Ms. Hughes. All were in favor and the motion passed.

**Public Health Updates – William R. Grow, MD, FACP**

- Dr. Grow provided the most current COVID-19 update, noting Tift has a total of 8,577 cases reported.
- The Omicron variant is affecting school-aged children and the unvaccinated much greater than others.
- Health departments have experienced a decline in requests for COVID testing and vaccinations.
- Currently, 42% of Tift residents are fully vaccinated.
- Board members were invited to attend the 92<sup>nd</sup> Annual Georgia Public Health Association Meeting and Conference scheduled for May 4-6, 2022 on Jekyll Island.
- Dr. Moreno opened the floor for nominations for board officers for 2022-2024. There were no new nominations from the floor, and none opposed maintaining the current slate of officers. All were in favor and the Tift County Board of Health officers remain with Dr. Raymond Moreno as Chair, Ms. Charlotte Bedell as Vice-Chair and Mayor Julie Smith as Secretary for 2022-2024.

**Financial Information - Teresa Giles (Attached)**

- Ms. Giles informed the Board the health department's budget increased by \$5,119 due to an inter-agency transfer from COVID funds for salaries.
- There were no other changes in revenue since the February meeting.

- Tift currently has five registered nurses, six administrative support staff and four environmental health staff. Some staff are shared with other counties and/or programs.
- Ms. Giles reported that the Tift County Board of Health's Fiscal Year 2022 Audit conducted by Robert Baker and Associates. There were no material weaknesses identified in internal controls and the only significant deficiency was one missed board of health meeting. There were no issues of non-compliance.

**Tift County Health Department Updates – Mecca Lewis (Attached)**

- Ms. Lewis began by noting the health department continues to provide rapid COVID testing 8:30 a.m. – 9:30 a.m. each Monday.
- Mako continues to administer PCR tests at the health department every Wednesday and Thursday. Their hours are 9:00 a.m. – 3 p.m. There is a decrease in testing.
- Janssen, Moderna and Pfizer vaccines are all available.

**Environmental Update – Tamika Pridgon (Attached)**

- Mrs. Pridgon provided an update on the 23 dog bites in the county between July and October of 2021. Six dogs were current on their rabies vaccinations, two were expired and four were unvaccinated. The rabies vaccination status of six were unknown. Ms. Pridgon further noted some owners did not return calls regarding their animals. Two bats, one raccoon and one squirrel were also tested during that time.
- One environmentalist who covers both Tift and Turner will be out on maternity leave.

**Diversified Enterprises Update – David Wilber (Attached)**

- Mr. Wilber presented Diversified Enterprises' Fiscal Year 2021 Audit Report from the Herring CPA Group. There were no material findings; however, there was one deficiency regarding the separation of duties. This is because Diversified is a small agency.
- Ms. Hughes made a motion to approve both the Tift County Board of Health's Fiscal Year 2021 Audit Report and Diversified Enterprises' Fiscal Year 2021 Audit report as presented. Ms. Moody seconded the motion. All were in favor and the motion passed.

- COVID-19 Impact:** We have started moving towards more face-to-face activities following the CDC Community levels guidance as a indicator of community transmission. An agency retreat is planned for June (outside) and we are starting other activities that bring the agency together. When the Public Health Emergency (PHE) ends some of the additional funding and flexibilities will end within 90 days. The agency is prepared for that transition.
- Vaccine:** No change in vaccination status. Our Direct staff vaccination rate is just below 70% closely mirroring vaccine rates in the communities we operate in. Most of our people supported received a Moderna vaccine and have received boosters out to those that want them.



3. **Financials:** The Monthly Financial report February is attached. The agency continues to be on solid financial footing. There is a 5% rate increase approved from July 1, 2021 that should roll out before June and will go back to July 21. We are hoping for a modest rate increase for FY23 from the state. Agency budgets are in process, and we are looking at another sight bump in the starting wage as well as a step after 6 months for Direct Support Professionals. Just a reminder that the reimbursement rates are based off a \$10.63 hourly wage, so a rate study is badly needed. There is legislation in play, and if it passes it will require a new rate study every 4 years to avoid these situations.
4. **Director Search Committee.** The search committee met with two internal candidates that were interested in the director position becoming available in 2023.
