

# Mark J. Eanes, M.D., M.B.A.



Dr. Mark Eanes is a board-certified ophthalmologist who has practiced in Valdosta, GA for 37 years. In addition to being on staff at South Georgia Medical Center, other past **medical affiliations** include the clinical faculty at Medical College of Georgia, Veterans Administration Hospital; and credentialed to practice medicine by the Peruvian Ministry of Defense.

He received his undergraduate degree in biology from Valdosta State University. His medical degree, medical internship and ophthalmology residency were completed at Medical College of Georgia, Augusta, and his MBA for Physician Executives at Kennesaw State University in Kennesaw, Georgia.

He has served in many leadership roles locally, including

Lowndes County Board of Health since 1993, chairman since 1994. As an active staff member of South Georgia Medical Center since 1986, he has served on many committees and held several positions, including Chairman of the Executive Committee and Chief of Staff. He has been involved in community organizations such as Leadership Lowndes, Boy Scouts of America, YMCA sports programs; and he has been a member of two school boards. He has also served as President of the VSU Alumni Association. Dr. Eanes has been involved in local not-for-profit organizations, including serving on the boards of The Mailbox Club and Options Now (crisis pregnancy center) where he has twice served as President of the Board of Directors.

Leadership on a state level includes many positions in the Georgia Society of Ophthalmology, serving as president in 1996-97. He has been on the Board of Directors of the Medical Association of Georgia, including the MAG Council of Legislation. He is currently on the Board of Managers and Finance Committee of Live Oak Accountable Care Organization (ACO) and has held key positions in the South Georgia Physician Network. He chaired the Board of Directors and served as interim CEO of South Georgia Health Partners (MCO) and has been involved in the South Georgia Medical Society, Georgia Health Decisions, Medical Resource Network, South Georgia Physician/Hospital Organization and Georgia Society to Prevent Blindness.

Because of his **compassion for the poor and impoverished populations**, Dr. Eanes established Heaven In Sight Missions in 2006, which has provided humanitarian relief in at least 16 developing countries around the world, serving in many of these countries multiple times. Heaven In Sight occasionally partners with other nation-wide organizations to further impact the under-served.

Dr. Eanes now considers the opportunity to help the under-served population locally a privilege, and he is looking forward to the contribution he can make to improve the overall health of Georgians, building upon the tremendous foundations of the passionate staff and leadership of South Health District.

#### Call to Order

• Dr. Fausett called the meeting to order at 12:05 p.m.

### **Public Comments**

• There were no public comments.

### Approval of October 18, 2022, Minutes (Attached)

• Col. (Ret.) Mitchell made a motion to approve the minutes from the October 18, 2022, meeting. The motion was seconded by Mayor Duke. All were in favor and the motion passed.

### **Business**

### Financial Information – Teresa Giles (Attachments)

- Ms. Giles presented the Cook County Health Department's Revenue and Expense Summary for July 1, 2022 through March 31, 2023.
- The budget has been increased by \$33,000 to cover state-approved salary increases for nurses, environmental health and other staff.
- Fee income decreased approximately \$11,000 compared to last year due to the decrease in demand for COVID vaccines. This decrease has occurred in all ten counties in the district.
- The fund balance is the best it has ever been, and Cook has approximately six months in operating expenses in the bank.
- The Cook County Board of Health's FY2022 Audit Report was presented to the Board. Cook's net position at the end of FY2022 was \$148,930 and the unassigned fund balance was \$345,306. No significant deficiencies were reported by the auditors. After a brief discussion, Ms. Keeley made a motion to accept the Cook County Board of Health's FY2022 Audit Report as presented. The motion was seconded by Ms. Robinson-McKenney. All were in favor and the motion passed.

### Public Health Updates - Dwain Butler

• Mr. Butler provided announcements on behalf of Dr. Grow.

- District staff participated in Abraham Baldwin Agricultural College's (ABAC) Health Equity Summit held April 17, 2023. Several universities from Georgia participated and shared their knowledge on health equity and equality. Next year, the district will send out information regarding the event so board members will have an opportunity to participate.
- Mr. Butler announced Dr. Grow's decision to retire June 30, 2023. The position has been posited and candidates have applied. Interviews with Dr. Kathleen Toomey, Commissioner of the Georgia Department of Public Health, will begin this month. Board members will have an opportunity to speak with the candidate once one is selected. All boards must reach a unanimous decision for the candidate to be hired.
- Travel-related information regarding GPHA will be e-mailed to each board member attending. GPHA will be held May 3-5, 2023 on Jekyll Island.

### Nurse Manager's Report - Rebecca Allgood (Attachment)

- Ms. Allgood announced Cook is open for all clinic and program services, including Family Planning, Sexually Transmitted Diseases, Immunizations, Breast and Cervical Cancer Program, Tuberculosis and other general clinic services. Many services are income-based and others are offered for low fees. Many private insurances, Medicare and Medicaid are also accepted as payment for services.
- Two nurse practitioners now come to the health department two times each week providing family planning services. One health department nurse is currently training to be checked off to provide long-acting reversible contraceptive methods as well.
- Staff vaccinated 250 students and 50 staff at Cook schools this past flu season. Flu vaccinations were also provided at Cook Community Bank. The health department also partnered with schools for events including Baby Hornets, APTT and Pre-K. These partnerships allow for outreach and provides an opportunity to inform the public about health department services.
- Local daycare audits have been completed for the year. Clinic staff worked with daycare directors to meet state requirements.
- COVID testing and vaccination services are still available as requested. The clinic also has
  free COVID at-home test kits available in the lobby for anyone who would like to request
  them.

### Environmental Update – Danielle Hurst – (Attachments)

- Ms. Hurst reviewed environmental health activity from January 1, 2022 April 18, 2023.
- Activities have remained abut the same with the exception of more permitting being processed for land use during the last several months.
- A mobile unit law has changed which allows owners to only need a permit in their county, which allows them to have their mobile unit in any county without needing additional permits.
- Ms. Hurst is also providing training Cook County's food service establishments.
- A water well and septic system loan program from Seven Rivers is available for qualified owners. A flyer was provided outlining the program. Ms. Hurst may be contacted for additional information.

#### **Announcements**

Mayor Duke announced the city is pursuing grant funding to replace lead pipes and connectors.
 Hopefully, this will prevent children from getting lead poisoning.

• There being no further business, Col (Ret.) Mitchell made a motion to adjourn the meeting. The motion was seconded by Dr. Dixon. All were in favor and the motion passed. The meeting was adjourned at 12:45 p.m.

# Opioid and Substance Misuse Response Program

**Mission**: To implement a sustainable, collaborative, and multi-disciplinary approach in response to Georgia's opioid and substance misuse crisis.

**Vision:** To improve access to state and local data; to recommend and/or implement education best practices; and to promote the use of law enforcement, healthcare, and public health resources to prevent the misuse of opioids and other substances in Georgia.

# Opioid-Related Overdose Deaths

Between 2017 – 2021, there were a total of 6 opioid-related overdose deaths for Cook county.



# Opioid-Related Overdose ER Visits

Between 2017 – 2021, there were a total of 36 opioid-related overdose ER visits for Cook county.

- 80.6% White American
- 13.9% African American
- 5.6% Multi-racial
- 50% Male
- 50% Female



# **Public Health Emergency**

June 2017 - First public health response to overdose cluster in Macon, GA due to fake Percocets laced with U-47700 and cyclopropyl fentanyl.

October 2017 – Former President Trump and Department of Health and Human Services (HHS) declare opioid crisis a public health emergency.



### Surveillance Activities

Syndromic Surveillance – Detection system reporting to DPH via hospitals based on patient's chief complaint and/or discharge diagnosis.

Vital Records and hospital reporting via DPH.

**ODMAP** – Application for law enforcement and first responders to report suspected overdose data across jurisdictions in near real time to support public safety and public health efforts in hopes to mobilize an immediate response to a sudden increase, or spikes in overdose events. The use of ODMAP by partnering agencies will bridge gaps in data collection.



# **Prescription Drug Monitoring Program**

The Georgia Prescription Drug Monitoring Program (PDMP) is an electronic database used to monitor the prescribing and dispensing of controlled substances. The PDMP provides prescribers and pharmacists with critical information regarding a patient's controlled substance prescription history. It can help eliminate duplicative prescribing and overprescribing of controlled substances and protect patients at risk of misuse.



# **Naloxone Standing Order**

Issued by DPH Commissioner Kathleen Toomey. Naloxone is available for all residents of the state of Georgia to ensure that family members, friends, co-workers, first responders, schools, harm reduction organizations, and others are able to provide assistance to a person experiencing an opioid-related overdose.



# **GA 911 Medical Amnesty Law**

Any person who in good faith seeks medical assistance for a person experiencing or believed to be experiencing a drug overdose shall not be arrested, charged, or prosecuted for a drug violation if the evidence for the arrest, charge, or prosecution of such drug violation resulted solely from seeking medical assistance. Any person who is experiencing a drug overdose and, in good faith, seeks medical assistance for himself/herself or is the subject of such a request shall not be arrested, charged, or prosecuted for a drug violation if the evidence for the arrest, charge, or prosecution of such drug violation resulted solely from seeking such medical assistance.
